होगाडे यांनी सोमवारी पत्रपरिपदेत सांगितले. लॉकडाउन काळात अनेक व्यवसाय, उद्योग बंद होते. अनेकांचे रोजगार गेले. त्यामुळे वीज बिल भरणेही त्यांना कठीण गेले. म्हणून केरळ, गुजरात, मध्य प्रदेश या तीन राज्यांनी वीज ग्राहकांना ५० टक्केच वीज बिल भरण्याची सवलत दिली. महाराष्ट्रात मात्र ग्राहकांना सवलत मिळाली नाही. उलट महावितरण कंपनीची वीज गळती १५ ते २० टक्के असल्याचे कारण देत ग्राहकांना दुप्पट बिल पाठवून लुटण्याचा प्रकार होत असल्याचा आरोप त्यांनी केला. ग्राहकांना मोठ्या प्रमाणात चुकीचे भरमसाठ रक्कमेचे बिल आल्याच्या तक्रारी वाढतच आहे. त्यावर आधी बिल भरा असे महावितरण कंपनीकडून ग्राहकांना सांगण्यात येते. पण ग्राहकांना वाढीव बिल भरण्याची गरज नाही. ग्राहकांनी याबाबत तक्रार केल्यास गेल्या सहा महिन्यांतील त्यांच्या वीज बिलाची सरासरी काढून ग्राहकाला बिल दिले पाहिजे. नंतर पाहणी करून त्याला योग्य रक्कमेचे बिल दिले पाहिजे. सरासरी बिलापेक्षा ही रक्कम जास्त असेल तर ती ग्राहकाला भरावी लागेल. पण चुकीचे बिल भरणे त्याच्यावर बंधनकारक नसल्याचे होगाडे यांनी सांगितले.
