## Instructions for Remote E-voting and E-voting during AGM:

- Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide the facility to Members to exercise their right to vote by electronic means on resolutions proposed to be passed at AGM. Members holding shares either in physical form or dematerialised form, as on Friday,14th June, 2024 (cut-off date), shall cast their vote electronically through electronic voting system (remote e-voting) of NSDL at <a href="https://www.evoting.nsdl.com/">https://www.evoting.nsdl.com/</a>. Only those Members whose names are recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date shall be entitled to avail the facility of remote e-voting. All the Members are hereby informed that the Ordinary and Special Business, as set out in Notice of 91st AGM will be transacted through voting by electronic means only.
- The remote e-voting period will commence at 9.00 A.M. (IST) on Sunday, 16th June, 2024 and will end at 5.00 P.M. (IST) on Thursday, 20th June, 2024. The remote e-voting module shall be disabled for voting after 5.00 P.M. (IST) on Thursday, 20th June, 2024.
- Once the vote on a resolution is cast by the Member, the member cannot modify it subsequently.
