Ms. Goyal has confirmed that she was not in possession of any Unpublished Price Sensitive Information (UPSI).

The Share Dealing Code Compliance Committee (SDC Compliance Committee) formed under the Share Dealing Code (the Code) and the Audit Committee of the Company, were informed and notified on the above-mentioned inadvertent trade. Based on the facts placed by Dr. Ashish Gupta, it was understood that it was an inadvertent trade made without any intent to violate the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015 (PIT Regulations) and the Code of the Company.

However, due to the breach of the Code and PIT Regulations, SDC Compliance Committee has imposed a monetary penalty of c. Rs. 9,00,000/- on the Independent Director and the penalty has been noted by the Audit Committee.
